SUMMARY

This bill will reduce gasoline vapors emitted into the air in order to reduce ground-level ozone. The measures included in this bill are expected to reduce hydrocarbons emitted in Maine by 11,000 tons per year, a 9% reduction over 1985 emissions. This bill adopts in statute rules the Board of Environmental Protection has promulgated to further reduce volatile organic compounds in Maine. In summary, these measures include:

- 1. Expanding the requirement for floating roofs and vapor recovery systems for bulk gasoline terminals statewide:
- 2. Reducing the volatility of gasoline during the summer months;
- 3. Installing "drop tubes" and vapor balance systems for major gasoline service stations; and
- 4. Requiring an annual self-certification leak test for gasoline tank trucks.

The committee amendment (H-176) clarifies certain provisions of the bill. It adds a definition of gasoline dispensing facility consistent with the Board of Environmental Protection's regulations. The amendment also removes two provisions of the bill enacting outdated schedules for compliance.

The amendment also clarifies that new requirements for vapor recovery systems are required for underground storage tanks scheduled for removal if they are replaced with new tanks.

A provision is added to require the Department of Environmental Protection to report back to the Joint Standing Committee on Energy and Natural Resources on the availability of 9.0 RVP fuel during the summer and any driveability problems experienced by vehicles as a result of this fuel.

The amendment also clarifies language relating to gas stations and bulk gasoline terminals that are subject to these gasoline disposal, storage and handling provisions.

SUMMARY

This bill would have amended the "Overboard Discharge" law (PL 1987, c.180) to change the relicensing standards. Under the proposed new standard, the Department of Environmental Protection would have denied relicensing applications only when it could demonstrate a violation of the license. (See also LD 1187).
