

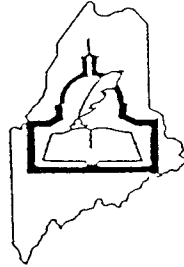

SUMMARY

The bill revised joint and several liability in medical malpractice cases to provide that liability is several and not joint with regard to noneconomic damages. (Carried over from the First Regular Session with the other medical malpractice bills.) Pursuant to Joint Rule 13, the President of the Senate and the Speaker of the House of Representatives required the bill to be reported out of Committee without a Committee Report.
