SUMMARY

This resolve establishes a blue ribbon task force to promote equity of opportunity for women in the public school system. The task force will study the current status of women in the public education system, including the representation and under representation of women in the public education system. The task force will submit a report outlining its findings and recommendations, including any necessary implementing legislation to the Governor and to the Second Regular Session of the 114th Legislature no later than February 15, 1990.

The committee amendment changed the membership and reporting date of the task force, shortened the amount of time allowed for appointments to be made, provided for the election of a chair and co-chair and authorized the task force to hire consultants, researchers and other support staff. The Senate amendment to the committee amendment (S-432) clarifies the authority for appointing members of the task force, requires that the chair and co-chair be legislators, establishes December 1, 1989 as the reporting date, and reduces the appropriation to \$35,000.

The bill would have prohibited approval of the construction of a new school building within a school administrative unit if any school building within the jurisdiction of that unit is operating at less than 80% capacity.

SUMMARY

This bill had 3 main objectives: it would have provided supplemental grants up to \$450 per year to teachers pursuing continued study or advanced degrees; it would have provided grants to school units of \$750 times the number of teachers employed to be used to enhance teacher salaries; and it would have provided grants to school units of \$2000 or \$20 per student to be used to improve the instructional quality of the school day. The salary grants were to begin in fiscal year 1989-90 and the continuing study grants and the quality of instruction grants in fiscal year 1990-91.

The committee amendment extended the continuing study grants to administrators and to secondary vocational education teachers seeking a bachelors degree and provided for use of local procedures for

determination of courses eligible for the grants. It also established the teacher salary grants as a state-funded program outside the School Finance Act and permitted the introduction of additional issues in collective bargaining over the use of the grants. Finally, the amendment clarified that the instructional grants were state-funded for 3 years and directed the DECS to report on how they should be funded after that.

This bill was carried over by the Appropriations Committee.

SUMMARY

Under current law, school units are eligible for state subsidy for some portion of their expenditures to lease portable, temporary classrooms. No subsidy is paid for the purchase or construction of portable classrooms. The bill makes the costs of purchasing or constructing portable, temporary classrooms eligible for subsidy. The bill also requires the commissioner to develop guidelines for schools to set up programs to build portable classrooms as part of the school curriculum.

The committee amendment (S-241) removes the provision requiring the department to establish guidelines for schools to develop programs to build portable classrooms. The amendment also clarifies that portable classroom purchases do not fall under the school construction approval process.

SUMMARY

This bill expands the list of high school graduation requirements a student may satisfy through the vocational school curriculum. Previously, vocational students could, with the approval of the Commissioner of Educational and Cultural Services, satisfy the second-year math, science and social studies diploma requirements through a separate or integrated course within the vocational school curriculum. This bill adds the fine arts diploma requirements to the list. This bill also corrects the reference to the second-year social studies requirements for high school students.
