This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The summaries are arranged by LD number for each committee.

All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

OTP	Ought to Pass
OTP-ND	Ought to Pass in New Draft
OTP-ND-NT	Ought to Pass in New Draft, New Title
OTP-A	Ought to Pass as Amended
ONTP	Ought Not to Pass

AMENDMENTS ADOPTEDSUMMARY

This bill would have amended the "Overboard Discharge" law (PL 1987, c. 180). The bill would have replaced the existing licensing standards with a requirement that these private discharges be evaluated in the same manner as municipal wastewater discharges. The Department of Environmental Protection would have been precluded from requiring the use of holding tanks. The department could have denied relicensing applications from persons with poor compliance records and could have required annual testing of residential overboard discharges and weekly testing of commercial overboard discharges at the licensee's expense. The committee voted not to pass the bill in favor of LD 1187.

AMENDMENTS ADOPTEDSUMMARY

This bill would have exempted from state-mandated local zoning and subdivision regulation freshwater wetlands that are determined by a municipality to be of no benefit to wildlife, ground water replenishment, plant habitat or flood control. This determination would have been made by the municipality in its comprehensive plan.

AMENDMENTS ADOPTEDSUMMARY

This bill would have granted the public a right-of-way on foot or by vehicle to any water impoundment in the State which was created by a dam authorized by State Government or Federal Government.

However, there were two constitutional problems with this bill. First, the public's right of access to a great pond involves only access by foot. Second, impoundments are considered private property and there is no guarantee of public access unless it is on a navigable waterway.
