All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

OTP	Ought to Pass
OTP-ND	Ought to Pass in New Draft
OTP-ND-NT	Ought to Pass in New Draft, New Title
OTP-A	Ought to Pass as Amended
ONTP	Ought Not to Pass
LVWD	Leave to Withdraw

SUMMARY

The bill provides that a security interest in property used in criminal activities is not subject to forfeiture if the holder had no knowledge of and did not consent to the criminal activity.

Committee Amendment "A" (H-296) specifically refers to "perfected" bona fide security interests.

**LD 1115     An Act Concerning Bed and Breakfast Establishments**

SUMMARY

The bill exempts bed & breakfast establishments from the prohibition against discriminating against families with children if the establishment has fewer than 10 rooms available.

Committee Amendment "A" (H-313) revises the language and provides that the exemption applies to lodging places with no more than 8 rooms available and in which the owner resides on the premises.

SUMMARY

The bill makes it one class of crime greater to commit a drug crime while using, carrying or possessing a firearm.

Committee Amendment "A" (H-324) includes "armed with" a firearm.
