LD 1125 An Act to Amend the Natural Resources Protection Act

#### SUMMARY

This bill and the committee amendment (H-399) make several technical corrections to the Natural Resources Protection Act passed last year. The committee amendment changes language within the Land Use Regulation Commissions's statutes relating to permits now covered under the Natural Resources Protection laws.

The amendment also updates the definition of coastal wetlands and amends language defining a freshwater wetland to include wetlands adjacent to surface water bodies that are 10 acres in size when combined.

Language to clarify that the natural resources protection law applies statewide is added as well as language to clarify that some erosion control work is approvable.

The amendment includes the stipulation that there be no additional intrusion of fill for maintenance work on private crossings. This brings the requirements for private crossings into conformance with requirements for public crossings.

Exemptions to forestry activities in areas adjacent to freshwater wetlands are included. Section 9 provides an exemption for soil borings which are typically taken as part of the data collection phase of a project.

#### SUMMARY

This bill would have established a Maine Solid Waste Authority to develop solid waste management facilities on an as-needed basis for the state. The Authority would have worked with 11 regional advisory boards corresponding to the existing regional planning councils and councils of government. This bill included planning criteria and a schedule for facility development. The committee voted not to pass the bill but did include several of its concepts in the committee's solid waste legislation, LD 1431.
