## SUMMARY

This bill would make uniform throughout Maine's system of long-term care procedures for assessing the needs of individual clients and tailoring programs to meet their needs. It would also provide the individualized treatment planning process with a set of articulated standards which ensure to each person in the system the least restrictive alternative for long term care and maximum feasible restoration of functional capacity. Finally, the bill addresses the need of Maine's long-term care system to have available to it data which identifies the needed services which are currently unavailable to long-term care clients.

The issues identified in this bill were included among the issues to be addressed by the study proposed in LD 747.

### SUMMARY

This bill amends certain sections of the Adult Protective Services Act to strengthen, expand and clarify the law. Changes in definitions include removing the term "willful" from the definition of abuse, expanding the definitions of "adult" to include emancipated minors, adding a definition of "sexual abuse", clarifying that the definition of "protective services" includes dependent adults, and clarifying the definition of "serious harm" for reporting to district attorneys.

This bill also includes certified nurse's aides under persons mandated to report abuse.

### SUMMARY

This bill is intended to clarify the Department of Human Services' authority to adopt rules establishing income thresholds under which individuals may receive public assistance for the payment of family planning services, including medically accepted contraceptive procedures. These thresholds may exceed those established for determining Medicaid eligibility.
