

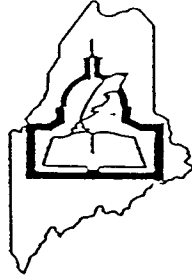

All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

SUMMARY

The bill established the New Crop and Livestock Research and Development Program in the Department of Agriculture, Food and Rural Resources. The bill also provided funds to implement information gathering, coordination of various state and federal agencies and to support feasibility, research and demonstration projects to evaluate and encourage new crop and livestock enterprises as well as new varieties of existing crops.

The bill was amended to include an appropriation of of \$22,000. Funding was not provided and the bill was indefinitely postponed.

SUMMARY

The resolve directed the University of Maine to assess the needs of horse-related industries in the state, but did not provide funding for the task. The resolve also established and provided expenses for the Commission to Study the Creation of a State Horse Council.

The amendment included the intent of the original resolve to establish the Commission to Study the Creation of a State Horse Council and made changes in commission appointments. The Department of Agriculture, Food and Rural Resources replaced the the University of Maine System as lead agency in conducting a needs assessment.

Funding was not provided and the bill was indefinitely postponed.
