All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

SUMMARY

LD 1246 proposed:

- A. To make the Director of the State Capitol Commission a member of the State Capitol Commission. The Director would be appointed by the Legislative Council;
- B. To redefine the geographic jurisdiction of the Capitol Commission to include property adjacent to the Capital Building;

AMENDMENTS ADOPTED

S-198

C. To authorize the Commission to consult with the city of Augusta to plan for the preservation and development of a unified park area including the State and City owned portions of Capitol Park.

The Committee amended the bill by striking the title and everything after the title. The Committee Amendment:

- A. Changes the name of the name of the State Capitol Commission to the State House and Capitol Park Commission in order to help lessen confusion between this Commission and the Capitol Planning Commission;
- B. Makes the State House and Capitol Park Commission advisory to the Legislative Council;
- C. Vests all approval authority and policy making authority with the Legislative Council in order to address the Separation of Powers problem which arises when a commission composed of members from different branches of government have policy making authority.

SUMMARY

GARLAND

LD 1259 proposed to place a constitutional limit of 5 consecutive terms on the number of terms that legislators could serve in each house of the Maine Legislature. This bill was very similar to LD 1014 which established a statutory ceiling on the number of terms a legislator could serve.

The bill failed to obtain committee approval because of the turn-over rate in the Maine Legislature and because of the principle that the electorate should be able to elect any person the electorate wants to represent it.
