LD 1267 proposed:

- A. To provide a range of educational subsidies to municipalities for each unit of affordable non-rental housing created in each municipality A non-rental housing unit is affordable if the sales price is affordable to persons with incomes of 80% or less of the median income for that municipality.
- B. That the range of subsidies be based on the sale price of each unit and different levels of income within a low income range.
- C. That the subsidies be determined by a formula based on median income.
- D. That the Commissioner of Education compute the amount of the subsidy in consultation with the State Tax Assessor, MSHA, and municipal inspectors.

The concept of this bill will be studied by the Committee in its study of obstacles to the development of affordable housing.
