All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

#### SUMMARY

The bill exempted from the definition of public records all documents and information collected or prepared by a governmental entity in the hiring process.

Committee Amendment "A" (S-252) (majority report) provides that the information on the person hired may be released once the person is hired.

Committee Amendment "B" (S-233) (minority report) provides that the hiring authority may release information on the applicants interviewed. (Not adopted)

House Amendment "A" (H-472) removes the emergency preamble and clause.

House Amendment "A" to Committee Amendment "A" (H-468) makes technical corrections.

Senate Amendment "A" to Committee Amendment "A" (S-256) would allow the disclosure of information on persons interviewed for major policy influencing positions. (Not adopted)
