This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The summaries are arranged by LD number for each committee.

All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

The bill failed to give the director of the office the necessary authority to implement the provisions of the bill. Other bills dealing with children were before the committee, and LD 1377 could be incorporated into a bill selected by the committee. In addition, the biennial appropriation required would have been roughly \$550,000.

SUMMARY

LD 1394 proposed that the 5 executive directors of the regional alcohol and drug abuse councils be included as members of the Maine Council on Alcohol and Drug Abuse Prevention and Treatment.

The Committee Amendment removed the ceiling figure of 5 executive directors and authorized the executive directors to appoint designees to represent them on the Council. Senate Amendment "A" increased the number of council members from 25 to 30.

SUMMARY

LD 1404 proposed that when state agencies hire classified employees through the use of registers of eligible applicants the hiring agency will receive the entire list of applicants and not a list limited to 6 names.

The bill failed to receive Committee approval for several reasons. For some job classifications, an entire list of applicants could include hundreds of names. The bureau of Human Resources is in the process of decentralizing hiring for many agencies and allowing many agencies to use direct hire procedures.

LD 1412 Resolve, Concerning Grant of Easement

SUMMARY

LD 1412 proposed that the State Bureau of Public Improvements grant an easement to the Hallowell Water District. The easement would be 50 feet wide by 926 feet long. The purpose of the easement is to allow the Water District to install an 8 inch water main to land owned by Maurice G. Blais.

State and Local Government/Part 1

The Committee amended the bill to require the Hallowell Water District to restore the excavated land to its original state, including topographical and drainage features. If the Water District exceeds its authority, the State will bring action for trespass against the district. The emergency preamble and clause were removed from the bill because of the constitutional prohibition of emergency land sales, transfers, or leases.

LD 1429 proposed that students with developmental disabilities who are enrolled in school supported work programs may apply and receive official state nondriver identification cards for \$2.

LD 1485 An Act to Require the Permanent Recording of the Location of Stone Walls

SUMMARY

LD 1485 concerned state agencies which undertake public improvements that destroy or remove landmarks. Current law requires state agencies to keep records of the precise locations of landmarks that are removed or destroyed by public improvements. LD 1485 proposed that state agencies record these records (descriptions) in the town office and the registry of deeds for the county in which the landmark is located.

The bill also proposed that whenever a state agency demolishes a stone wall, the precise location of the former stonewall would be recorded in the town office and the registry of deeds for the county in which the stonewall was located.

The bill failed to receive Committee approval because of the impact on the State, especially the Department of Transportation. The bill appeared to strive to preserve cultural or historical landmarks which would be very costly to the State.
