#### SUMMARY

This bill sought to require that hunting licenses be weather resistant, of sufficient size to contain at least 10 authorizations of land use and contain an identification number which must be in characters at least 4 inches high. The bill would have made it an offense to hunt for animals and birds without wearing the license. The license was to be worn on the upper body with the identification number of the license visible.
