SUMMARY

This bill, as amended (H-283), set aside one third of the funds available for the closure and cleanup of municipal landfills to reimburse those eligible towns that have already completed acceptable closure and cleanup programs. The Board of Environmental Protection may use more than one third of these funds if warranted. The amended bill also includes interest paid on municipal bonds issued for landfill closures in the costs eligible for state reimbursement.

This bill proposed taking 2 steps to reduce the risk airborne nuclear pollutants pose to the people of the State.

Section 1 of the bill dealt with health risks associated with milk contaminated by radioactive iodine. It would have prohibited the sale of any milk that was contaminated by more than one picocurie of radioactive iodine.

Section 2 of the bill would have required the Bureau of Health, Division of Health Engineering, in consultation with the Department of Environmental Protection, to study and determine whether federal standards for maximum permissible levels of airborne radioactive emissions from nuclear power plants are adequate to protect public health and safety.
