SUMMARY

This bill would have required the implementation of a student assessment system in the University of Maine System by the 1990-91 school year. The Board of Trustees of the System would have developed a method to ensure the entry-level, graduation and post-graduation assessment of students. The Board of Trustees would have submitted a report, including guidelines and recommendations necessary to the implementation of the student assessment system, and any necessary implementing legislation to the Legislature on or before December 1, 1989.
