All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

CA (H-522) The amendment reduces the project to a single site, to be selected by DOT in the most feasible location based on use, municipal approval and access to disposal capability. LD 1541 ONTP An Act to Require Foreign Recreational Vehicles to Purchase a Fuel Use Decal SPONSOR(S) COMMITTEE REPORT AMENDMENTS ADOPTED ROLDE ONTP SUMMARY This bill requires recreational vehicles which are based in another jurisdiction but which operate in Maine to purchase an annual fuel use identification decal.
