#### SUMMARY

The bill would specifically provide that a condition of probation may be participation in a substance abuse treatment program, and that non-identifying statistics could be collected and released by the Department of Corrections.

Committee Amendment "A" (H-513) retitled the bill and replaced the text of the bill. It requires the Director of the Division of Probation and Parole to collect probation treatment statistics and make the information available.
