This bill establishes specific standards of care for the treatment of Maine's mentally ill citizens. The bill requires the Department of Mental Health and Mental Retardation to put the standards into

place, to report on progress toward compliance with the standards, to review the needs of all residents who have lived at a state institution for more than 60 days and to conduct an annual review of unmet patient needs. The bill funds staff and facility improvements at the Augusta Mental Health Institute and the Bangor Mental Health Institute.

SUMMARY

This bill provides HIV antibody testing, AIDS education and prevention programs for those convicted of or pleading to drug, prostitution and sex-related offenses, behaviors that are considered to be at high risk for acquiring and transmitting the Human Immunodeficiency Virus or HIV.

These programs are intended to motivate convicted offenders by offering a reduction in sentences or fines in exchange for participation in counseling, education and antibody testing.

This bill provides matching state funds to start a program, Operation HEAT, that offers convicted intravenous drug users and sex offenders the option to volunteer for AIDS testing. The bill also provides funds for case management services, AIDS education, counseling and substance abuse treatment and rehabilitation programs.

SUMMARY

PENDLETON

This bill grants authority to the Commissioner of Mental Health and Mental Retardation to appoint an interim superintendent of the Augusta Mental Health Institute. It extends the protection of the Maine Tort Claims Act to Health Consortium, Inc., and persons and entities contracting with Health Consortium, Inc. to assist and advise the Department. It also specifies the ability of the Legislature to request information from the interim superintendent and the Consortium and indicates the intent of the Legislature that the costs of this bill will be paid from the Governor's contingency account.
