#### **SUMMARY**

This bill defines the word apprentice, increases by 1 year the experience requirement to sit for a journeyman examination, and describes the employment and supervision requirements of journeymen plumbers.

Committee Amendment "A" accomplishes the following:

- 1. Eliminates specific licensing fees and gives the Plumbers' Examining Board authority to set fees;
- 2. Requires that the board make a recommendation to the Legislature concerning continuing education;
- 3. Changes the 2 current ways of obtaining a journeyman license from 4,000 hours as a trainee to 8,000 hours plus a 45-hour course on the state plumbing code and from 2,000 hours as a trainee and one academic year to 4,000 hours and one academic year. It also adds a 3rd method of licensure requiring a trainee to complete an apprenticeship under a state-registered program plus 576 hours of classroom instruction:
- 4. Eliminates 8,000 hours as a trainee as a route to obtaining a master's license, leaving 2,000 hours as a journeyman as the only route to the master's license;
- 5. Requires that all supervised training be under the direct supervision of the designated supervisor;
- 6. Indicates that the Department of Professional and Financial Regulation will employ a person to supervise the apprentice program. That person will be paid from funds generated from an increase in licensing fees.

House Amendment "A" changes Committee Amendment "A" to require general supervision rather than direct supervision by a master plumber as one of the qualifications for a master plumber license. The amendment also provides that a graduate of a Maine technical college, having successfully completed a course of study in plumbing, is qualified as a master plumber.
