All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

SUMMARY

The bill exempts group Medicare supplement policies from the statute mandating benefits for substance abuse and mental illness.

The committee amendment (H-547) deletes language exempting Medicare supplements from the substance abuse and mental illness mandate, and inserts language exempting policies that supplement the Civilian Health and Medical program of the Uniformed Services (CHAMPUS) from that mandate.

SUMMARY

The bill requires the manual rates and rating plans for workers' compensation insurance in the voluntary and involuntary market, which are developed by rating organizations, to include rules for prorating the rates for employees falling into more than one classification. Currently, those employees are generally placed in the classification with the highest risk.

H-477     RYDELL

SUMMARY

This bill amends the Banking Code to specifically include the Treasurer of State, Abandoned Property Division as a "supervisory agency," to allow its auditors access to confidential records of credit unions and financial institutions.

HA (H-477) was offered with the support of the committee, since the bill was engrossed without reference. This amendment makes it clear that disclosure of financial records to the Treasurer in the performance of his duties under the Abandoned Property law, Title 33, chapter 37, is not prohibited under the confidentiality restrictions of the Bank Code, Title 9-B. The amendment avoids the term "supervisory agency" which is normally used for agencies with bank regulatory functions.
