LD 879 requires all state employees who are required to use respiratory rescue equipment to receive training in the proper use of the equipment. The training must meet the OSHA requirements for firefighter training in the use of respiratory equipment.

SUMMARY

LD 908 proposed to create a Workers' Compensation Logging Industry Fund to reduce workers' compensation insurance costs for logging employers. The fund would be established by an assessment upon all insurers and self-insured employers in the state and would pay the costs of any logging industry claim exceeding \$25,000.

SUMMARY

LD 1747 was initially referred to the Energy & Natural Resources Committee which carried it over to the 2nd Regular Session. After being reported from that committee, it was re-committed to the Labor Committee. LD 1747 proposed to require any commercial or industrial facility that had over 250 employees and that used hazardous equipment or substances to cease operation if more than 1/2 of the employees at the facility had worked there for less than 6 months. The facility was not permitted to resume operation until the Bureau of Labor Standards had inspected the facility and found it to be safe for operation.

Committee Amendment "B" (H-1050) was the majority report of the committee and made several changes to the original LD, including the following:

1. Allowed the facility to continue operations while the inspection was conducted;

- 2. Reduced the threshold number of employees from 250 to 50;
- 3. Permitted the Bureau of Labor Standards to contract with private parties to conduct the inspection and further provided that all costs of the inspection were to be paid by the facility operator; and
- 4. Made several other minor changes to the original LD.

Committee Amendment "C" was the minority report of the committee and provided for an inspection of a facility using hazardous substances when more than 1/2 of the employees who were assigned to handle those substances had worked in that capacity for less than 6 months. The inspection was coordinated by the Commissioner of Environmental Protection and was intended to determine compliance with existing legal requirements related to the use of hazardous substances.

LD 1871

LD 1871 proposed to resolve workers' compensation apportionment claims by simply dividing liability on a pro rata basis among the various insurers or employers. It also prevented any reapportionment if the later injury occurred more than 2 years after an earlier injury for which apportionment would otherwise be due.

SUMMARY

LD 1880 proposed to increase the workers' compensation burial allowance from "up to \$1,000" to "up to \$5,000" and also increase the incidental compensation paid as a result of an employee's death from \$1,000 to \$25,000.

Committee Amendment "A" (H-786) increased the burial allowance to a maximum of \$4,000 and increased the incidental compensation to \$3,000. It also provided that the burial reimbursement would be paid to the person responsible for the funeral costs and the incidental compensation would be paid to the employee's estate.
