LD 1669 proposed to establish a budget committee for Kennebec County to be elected by the municipal officers. The budget committee has final authority to approve the county budget.

Committee Amendment "A" (S-323) provided for the county commissioners to nominate budget committee members, subject to confirmation by the Kennebec County legislative delegation and added a sunset clause to repeal the budget committee statute on March 1, 1991.

House Amendment "A" to Committee Amendment "A" (H-634) substituted the full Legislature for the county legislative delegation for the purpose of confirming the county commissioners' nominees to the budget committee.
