#### SUMMARY

This bill authorizes \$21 million bond issues as follows, subject to statewide referendum in November 1989:

- \$17 million for the Highway Fund for highway and bridge improvements;
- \$1 million for the General Fund for airport improvements; and
- \$3 million for the General Fund for harbor improvements.

The bill allocates the Highway Fund portion for FY90 and FY91, but does not appropriate airport and harbor funds.

#### **SUMMARY**

This bill addresses a local development corporation or a nonprofit corporation that has been formed by a municipality to manage or market land or facilities that have been improved with the funds authorized by a certain bond issue.

HA (H-618). This amendment was offered in lieu of a committee amendment. It carries out the intent of the original bill but limits it to implement the organization of the Portland Fish Pier Authority as a quasi-municipal nonprofit local development corporation. As such, the authority would be covered by the Tort Claims Act and the Freedom of Access Act, including the immunities and the availability of executive sessions under those acts. In addition, the amendment will permit the Commissioner of Transportation to serve upon the board of directors. The faith and credit of the state is not pledged by the presence of the commissioner on the board.
