All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are abbreviated as follows:

#### SUMMARY

LD 1750 proposed to create a finance committee for Aroostook County to establish the county budget, subject to a potential override of their determination by unanimous vote of the county commissioners. The finance committee could similarly override the county commissioners' determination by a 2/3 vote of the finance committee.

Committee Amendment "A" (H-632) provided for the direct election of finance committee members in every even-numbered year, made other minor corrections and provided that the LD would not take effect unless the voters of Aroostook County approve the recommendations of the Aroostook County Charter Commission. If approved, the Act will take effect to establish 1992 Aroostook County budget.

#### SUMMARY

LD 1755 proposed to authorize Cumberland County to issue \$25,000,000 in bonds to construct a new jail facility, contingent upon ratification of the LD by the voters in a county referendum.

Committee Amendment "B" (H-628) requires Cumberland County to negotiate with the municipality in which the new jail is to be located for the payment of service fees in lieu of taxes.
