LD 1800 allows Aroostook County to renovate the Houlton District Court by using interest accumulated on money from a bond issue to construct a new jail. The Aroostook County commissioners may make a one-time transfer of up to \$200,000 of the interest to the county's contingent fund to be used in the courthouse renovations, if the commissioners find it necessary.

LD 1809 makes certain laws that were enacted in the First Regular Session of the 114th Legislature emergencies so that the duties prescribed by the laws would be completed before the reporting deadlines. This bill applies to the Advisory Committee on Home Health, the Affordable Housing Alliance Advisory Committee, the Interagency Task Force on Homelessness and Housing Opportunities and the Commission on Manufactured Housing.
