An Act to Amend the Laws Relating to the Purchase of Military Service Credits by Members of the Maine State Retirement System **PUBLIC 907**

SUMMARY

Current law allows credit for service in the armed forces to members of the Maine State Retirement System if they began membership prior to January 1, 1976, except in the case of Vietnam veterans who must have begun state service prior to January 1, 1988. This bill allows credit to Vietnam veterans regardless of when their state service began.

Committee Amendment "A" adds service during any period of conflict to this exemption from the state employment date requirement.

Senate Amendment "A" to Committee Amendment "A" prohibits the use, without legislative approval, of a position in state government that becomes vacant due to the Governor's program to reduce the state work force through an employee incentive program. This approval is to be requested in the next services budget. There is an exception to this prohibition when the health or safety of the public is involved. The Department of Administration is to submit a list of all vacancies to be filled to the Appropriations Committee by August 1, 1990.

SUMMARY

The law presently permits members of the Retirement System to make payments of back contributions, repayment of withdrawn contributions and payment of contributions for military service, out-of-state service and private and parochial school teaching service, on an installment basis, either by direct payment or by payroll deduction. This bill requires these payments to be made in a single payment. This bill also amends the group life insurance program to provide a basis for setting the amount of a participant's insurance coverage in such a manner that the level of coverage and amount of premiums collected may be reconciled and audited by the automated system.

Committee Amendment "A" allows payments for service credit to be made in annual direct payments and allows those currently utilizing payroll deductions to continue to do so.

House Amendment "A" adds a fiscal note to the committee amendment.
