SUMMARY

Currently, the law requires the State to pay 100% of the health insurance premium for state employees and retirees but requires nothing toward dependent coverage for state employees and retirees, other than legislators. However, through collective bargaining, the State is required to pay 60% of dependent medical premiums for active employees.

This bill requires the State to pay 60% of the health insurance premium for dependent coverage for retired state employees.

Committee Amendment "A" changes the figure for State participation to 10%.

SUMMARY

This bill sets up a commission to study the possibility of making retired teachers health insurance premium payments by the State equal to premium payments for all other state employees in the Maine State Retirement System.

Committee Amendment "A" changes the composition of the study commission by substituting one member of the Joint Standing Committee on Banking and Insurance and of the Joint Standing Committee on Appropriations and Financial Affairs for one of the 2 members of the Joint Standing Committee on Aging, Retirement and Veterans and of the Joint Standing Committee on Education. It eliminates one of the 2 teachers, the member from the Maine State Retirement System and one of the 2 appointees from the Maine School Management Association. In their place are added an appointee of the Maine State Retired Teachers Association, a representative of Blue Cross and Blue Shield of Maine and a representative from a private company that provides self-insurance.

Committee Amendment "A" also adds material that specifies the questions to be examined and the method for examining them to the section dealing with the duties of the commission. The addition of this material is in accordance with the directions of the Legislative Council.

Lastly, Committee Amendment "A" indicates that if the commission is assigned staff by the Legislative Council, it must complete its study by October 1, 1990 and submit its report and legislation by November 1, 1990.
