SUMMARY

LD 1950 authorized the Town of East Millinocket to annex certain land in TR 7 WELS upon a combined vote of the town and the township residents.

Committee Amendment "A" (S-547) authorized the annexation of a second parcel of land in TR 7 WELS and required the local referendum ballots to be counted separately in the town and in each of the 2 parcels sought to be annexed.

House Amendment "A" to Committee Amendment "A" (H-900) required separate election dates for voting on the annexation of each of the two parcels sought to be annexed by the town and required the Town of East Millinocket to pay any costs associated with either annexation.

House Amendment "B" to Committee Amendment "A" (H-955) deleted a requirement concerning the minimum number of voters at the referenda.

SUMMARY

LD 1966 originally required the State to reserve space within the State House Complex for a memorial to firefighters who died in the line of duty.

Committee Amendment "A" (H-756) to LD 1966 amended the resolve to commemorate all past and future firefighters who give their lives in the line of duty and required that the location for the memorial be decided by the Special Committee on the New Capitol Area Master Plan. In the event that the Special Committee does not decide upon a location for the memorial by January 1, 1991, the location may be agreed upon by the State House and Capitol Park Commission and the Maine Fire Chief's Association.

House Amendment "A" (H-764) to Committee Amendment "A" adds the Professional Firefighters of Maine and the Maine Federation of Firefighters, Inc., to the list of organizations participating in the selection of the location for the Memorial.
