

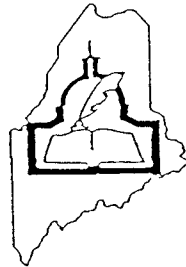

SUMMARY

This bill, as amended (S-561 and S-574), requires a utility which files a petition with the Public Utilities Commission to construct a transmission line to send a copy of that petition to each municipality in which the line is to be located. It also authorizes a utility to petition for a certificate of public convenience and necessity for construction of a facility prior to applying for approval under relevant municipal ordinances.

SUMMARY

The original bill sought to require the Public Utilities Commission to consider the environmental impacts of public utility services in utility proceedings. As amended (H-925), the bill requires the Public Utilities Commission to conduct an analysis of the various ways to include consideration of the environmental and economic impacts of alternative energy resource plans in utility energy planning. The commission is required to report the results of the analysis, including proposed legislation, to the Joint Standing Committee on Utilities by April 1, 1991. The title was amended to reflect the changes in the committee amendment.

SUMMARY

This bill originally sought to amend the fuel adjustment clause to provide better incentives for energy conservation and for minimizing ratepayer cost. The bill, as amended (H-809), requires the Public Utilities Commission, in consultation with the State Planning Office and the Public Advocate, to review the fuel cost adjustment authorized by the Maine Revised Statutes, Title 35-A, section 3101, and submit an analysis of the fuel cost adjustment and the extent to which it meets or impedes the objectives of the Maine energy policy and the Electric Rate Reform Act set forth in Title 35-A, chapter 31, subchapters III and VI. The findings, recommendations and proposed legislation from this review will be submitted to the Joint Standing Committee on Utilities by October 1, 1990. The title was amended to reflect the changes in the committee amendment.
