

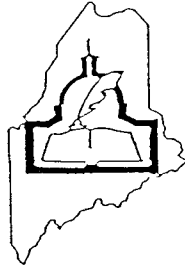

All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. Committee Reports and Floor Action are abbreviated as follows:

SUMMARY

The bill, as amended by the committee amendment, established a formal "red tide" monitoring program for mahogany quahogs by creating a mahogany quahog license and an industry group in each harvesting area responsible for scheduling mahogany quahog harvesters to assist the Department of Marine Resources sampling program. The Senate amendment changed participation in the monitoring program from a mandated license condition to a voluntary program.

SUMMARY

This bill, as amended by the committee amendment, conforms state law to the federal standard for the maximum allowable release rate of tributyltin in antifouling paints. The amendment provides that this new state standard is repealed September 1, 1992. The current, more stringent state standard for the maximum allowable release rate of tributyltin becomes effective once again on September 1, 1992. See also LD 2124.

SUMMARY

The bill, as amended by the committee amendment, makes technical changes in the statutes governing the Department of Marine Resources, gives the Commissioner of Marine Resources the ability to promulgate rules on limits and methods of capture for striped bass and reenacts 12 MRSA § 6862, in order to regulate the processing of lobster tails.
