

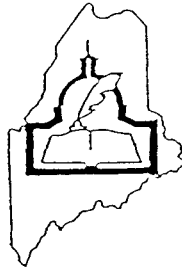

The bill amends the ASPIRE program to allow the Department of Human Services to bring the State into conformity with the federal Family Support Act of 1988. The bill repeals the sunset provisions of the ASPIRE statutes.
