LD 2218 An Act to Require School Transportation for High School Students

SUMMARY

LD 2218 would have required municipalities that are members of school unions to provide transportation to school for secondary school students. Current law requires municipalities that are members of school unions to provide transportation to and from school only for their elementary school students. The Committee found that all but a handful of municipalities already provide transportation for their high school students. The bill was withdrawn because of its high cost, because the small number of towns which are not providing transportation did not seem to warrant a state mandate at this time, and because there are voluntary alternatives available to provide such transportation.

SUMMARY

HIGGINS MACOMBER

LD 2245 would have provided state financial assistance to public schools to meet the rehabilitation costs incurred as a result of conforming with federal and state rules and regulations regarding the removal of hazardous wastes. The financial assistance formula would have been given in accordance with a formula based on the local tax burden.

Reimbursement for these costs is included in the Committee Amendment to LD 83.

SUMMARY

FOSS

LD 2261 would have amended the education funding formula to require that the personal income of residents in a school administrative unit be taken into consideration in determining the ability of the unit to fund education. The current formula measures a unit's ability to pay for education only on the basis of its property value. This bill would have added a second adjustment to the property value of each unit, under which the value would have been multiplied by a ratio comparing the per capita income of the county in which a unit is located with the state average per capita income. This would have lowered state valuation of units in counties with below-average income to reflect their lesser ability to pay, and thus would have resulted in greater state education funding. This bill also would have required the Department of Education to report annually to the Legislature the numbers used in adjusting valuation.
