### **SUMMARY**

LD 2270 establishes the Commission to Assess the Impact of Increased State Spending on the University of Maine System. Membership consists of 7 voting members including representatives of the Legislature, students, faculty and Board of Trustees of the University of Maine System. One nonvoting ex officio member representing the Office of the Chancellor of the University of Maine System would also be a member of the Commission.

The specific impacts to be studied include: construction projects on campuses; acquisition of equipment, supplies and services; impact on the quality, size, rate of turnover and morale of the faculty; improvements in the quality of student life; improvements in academic offerings and distribution of funding among the campuses. The Commission is to report to the First Regular Session of the 115th Legislature and the Office of the Chancellor by December 1, 1990.

Committee Amendment "A" (H-928) adds a voting legislative member to the Commission and revises the appropriation section to accommodate that change.

House Amendment "A" (H-998) to Committee Amendment "A" amends the nomination procedure for appointing members to the Commission.

Senate Amendment "A" (S-729) to Committee Amendment "A" implements several steps to reduce the cost of the Commission such as: removing the provision of per diem for Legislators; removing the General Fund appropriation; removing the legislative staffing requirement and requiring the University of Maine System to absorb the remaining costs of the Commission.

#### SUMMARY

LD 2295 would have established an annual reporting requirement to the Joint Standing Committee on Education for any corporation formed to operate in the secondary market to purchase student financial aid loans from banks and other institutions. (The Maine Education Loan Marketing Corporation, MELMAC, is the only corporation currently performing that function.) Current law authorizes the formation of one or more nonprofit corporations to operate in the secondary market and sets aside a portion of the State's tax-free bond limit for that purpose. This requirement would have provided for the monitoring of this essentially public purpose by private corporations. Similar reporting requirements were provided in LD 2275 (PL 1989, c. 812) enacted this session and this bill was indefinitely postponed.
