

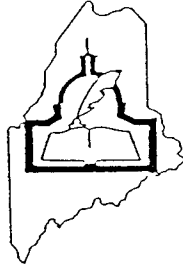

**LD 2289 An Act to Prohibit the Development of Spaghetti-lot
Subdivisions**

SUMMARY

This bill prohibits the formation of so-called "spaghetti-lots" in the unorganized territories and in any proposed subdivision undergoing municipal review.

The committee amendment (S-553) allows additional exemptions to the spaghetti-lot prohibition included in the bill to allow for narrow lots for such purposes as public boat launches and wildlife travel corridors.

SUMMARY

This bill reestablishes an enforcement tool that was repealed in 1989. Until the enactment of Public Law 1989, chapter 174, section 9, forest rangers were accorded the power after an arrest to accept personal recognizance with a deposit for any criminal violation they enforce. This power was removed from the forest rangers last session because of possible perception of impropriety occasioned by the acceptance of money from an arrested person by a law enforcement officer. However, because forest rangers work in remote areas of the state, the personal recognizance bond is too valuable an enforcement mechanism to eliminate. Game wardens still possess this power.

A committee amendment (H-844) adds an emergency preamble and clause and corrects a technical error.

SUMMARY

This bill would have established standards controlling the discharge of color pollutants to the waters of the state. These standards would have been based primarily on the impact of the discharges on ambient conditions. (see also LD 1970)
