SUMMARY

This bill would establish a pilot project halfway house for substance abusing pregnant women and mothers of infants.

SUMMARY

This bill would permit the Department of Human Services to refuse to provide payment for persons in boarding homes who did not meet the standard of medical need for the Medicaid program. It would also have deleted from current law requirements of the Department for which funds have not been appropriated.

The majority vote of the Committee was Ought Not to Pass. The minority Committee Amendment would have permitted the Department to refuse payment only if another housing alternative was available.

SUMMARY

The original bill permits the Department of Human Services to require a long-term care facility to transfer residents in an emergency that threatens the health, safety or welfare of the residents of the facility. It also would provide that penalties assessed against long-term care facilities would not be stayed during an appeal of the assessment.

The Committee Amendment requires the Department to assist in the transfer of residents and retains current law whereby collection of penalties is stayed during an appeal.

SUMMARY

This bill would require the Department of Human Services to develop a poison warning symbol and program designed to educate and alert children to the dangers of household products.

The Committee Amendment made minor revisions to the program and added an appropriation.

SUMMARY

The bill codifies Department of Human Services' rules regarding depreciation for cost-reimbursement boarding homes.

Committee Amendment "A" allows the Department of Human Services to negotiate a depreciation schedule that varies from the rules if a service provider can demonstrate that assets are consumed at a more rapid rate than allowed in the rules.

Committee Amendment "A" clarifies that the Council may receive and spend funds from sources other than the General Fund.
