

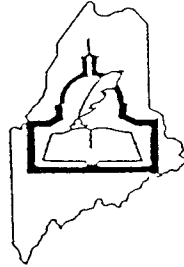

SUMMARY

The bill, amended by Committee Amendment "A" (S-682), makes technical corrections in the laws of Maine.

Senate Amendment "A" to Committee Amendment "A" (S-684) contained the same corrections as are in House Amendment "D" to Committee Amendment "A". (Not adopted)

Senate Amendment "B" to Committee Amendment "A" (S-688) excluded from the definition of "real estate appraiser" a governmental officer or official acting in an official governmental capacity for licensing and registration purposes. (Not adopted)

Senate Amendment "C" to Committee Amendment "A" (S-690) extended the sunset on special seasonal agency liquor stores to January 15, 1991. (Not adopted)

House Amendment "A" to Committee Amendment "A" (H-1104) corrects an error in landfill closure license fees.

House Amendment "B" to Committee Amendment "A" (H-1106) clarifies application of mobile home warranty laws.

House Amendment "C" to Committee Amendment "A" (H-1107) repealed the law consolidating Misery-Sapling Gore with adjoining townships. (Not adopted)

House Amendment "D" to Committee Amendment "A" (H-1108) contains substantive corrections approved by the Committee.

SUMMARY

The bill granted eminent domain powers to the Atlantic Sea Run Salmon Commission to acquire the Edwards Dam. See LD 2508.
