#### SUMMARY

New Draft of LD 2149

This new draft increases the membership of the advisory council to the Department of Inland Fisheries and Wildlife from 8 to 10 and establishes representation largely on the basis of population centers, rather than on wildlife management units, through the use of county lines. It also prohibits the following from serving as a members of the advisory council: legislators, former employees of the Department of Inland Fisheries and Wildlife within one year of department service or former legislative members of the Joint Standing Committee on Fisheries and Wildlife within one year of committee membership.

The new draft was amended (H-880 and H-818 as amended by S-623) to add an allocation to provide funds  $_{\bullet}$  for the 2 new advisory council members.

## SUMMARY

This bill was reported out by the Joint Standing Committee on Fish and Wildlife to provide general fund reimbursement to the Department of Inland Fisheries and Wildlife for search and rescue operations performed by that department. It was referred to the Joint Standing Committee on Appropriations and Financial Affairs. The Appropriations Committee reduced the general fund appropriation slightly.
