#### SUMMARY

This bill, as amended by the committee (H-1055), provides a procedure to limit the amounts of toxic substances allowed in the State's surface waters, removes certain legal uncertainties that have delayed the regulation of these toxic substances and implements a requirement in the Federal Water Pollution Control Act that the State must meet for the control of toxics. The bill requires the Board of Environmental Protection (BEP) to use the numeric water quality criteria of the United States Environmental Protection Agency (USEPA) in regulating "priority" toxic pollutants unless the board chooses to substitute an alternative water quality criteria that is based on a "sound scientific rationale" and is "protective of the most sensitive designated use of the water body". Use of the USEPA criteria for dioxin is suspended until June 1, 1991, to provide time for the BEP to consider adoption of an alternative criterion for this pollutant. The amended bill also directs the BEP to establish a compliance schedule for dioxin control that is consistent with the compliance deadlines established by the Federal Water Pollution Control Act. Finally, the amended bill extends the existing dioxin monitoring program for 5 years.

#### **SUMMARY**

This bill allows families whose wells have been contaminated by hazardous substances, and who need public water for potable water, to receive subsidies to keep their rates comparable with water rates throughout the State.

The Committee amendment (H-943) allows the Department of Environmental Protection to pay the costs of a public water supply for up to 20 years if funds are available from dedicated revenue accounts or from applicable bond proceeds.
