

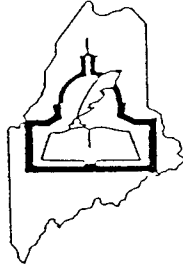

All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. Committee Reports and Floor Action are abbreviated as follows:

This bill, as amended by the committee (H-924), prohibits the Board of Environmental Protection, in determining whether the Squa Pan Stream supports the designated uses of its water quality classification, from considering the impact to the waters caused by the operation of the Squa Pan Hydro Project.

**SUMMARY**

This bill, as amended (H-1065 and H-1094), requires the Department of Environmental Protection and the Maine Land Use Regulation Commission to adopt or amend rules to regulate the environmental effects of mining in this State. A one-time allocation from the Hazardous Waste Fund will be used to pay the costs of developing and adopting the rules. A preapplication fee for nonferrous metal mining is established at \$20,000 and these funds, together with any federal money received to develop mining rules, are dedicated to repaying the one-time allocation from the Maine Hazardous Waste Fund. The bill also requires an annual license fee for permitted facilities to a maximum of \$10,000.

The bill also defines nonferrous metal mining and specifically prohibits uranium and thorium mining in this State. An appropriation section, allocation section and fiscal note are added to the bill.

**SUMMARY**

This bill would have established new fees and increased some existing license and certification fees of the Department of Environmental Protection. The bill replaced L.D. 2360. Portions of this bill that would have tied the cost of an air emission license directly to the quantity of emissions were also submitted as L.D. 2493 and 2511, and were included in the majority report on L.D. 2445.
