SUMMARY

LD 2457 would have required the Commissioner of Education, with the advice of members of the statewide association of teachers, principals, superintendents and school boards, to establish criteria and procedures for granting waivers of state mandates. Waivers would be for a 12-month period and subject to reapplication and review. The provisions of this bill would be repealed on September 1, 1992.

Committee Amendment "A" (H-1052) replaces the original bill. This amendment requires the Commissioner of Education to meet with appropriate statewide organizations and professional associations to discuss and disseminate information to superintendents and school boards wishing to apply for waivers. The Commissioner is also required to report to the Joint Standing Committee on Education on the status of education mandate waivers by January 1, 1991. The provisions of this bill are repealed on July 1, 1991.

SUMMARY

The purpose of LD 2472 is to promote the study and understanding of the importance of the philosophies underlying certain documents important to the founding of this country. Those documents are the Declaration of Independence, the Constitution of the United States and the Federalist Papers. School administrative units are encouraged to provide appropriate learning opportunities for students on these subjects and to require demonstration of familiarity with them. The Department of Education, school boards and the teacher education preparation programs at post-secondary educational institutions in the State, as appropriate, are encouraged to establish curriculum content and provide for in-service and preservice teacher training to ensure that teachers are adequately prepared and supported to carry out the intent and provisions of this resolve.

Senate Amendment "A" (S-659) adds a fiscal note to the resolve and corrects references to the Department of Education.
