This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 24**      **Resolve, Authorizing Mark Tamecki to Bring a Civil Action against the State**      **LV/MD**

### SUMMARY

This resolve would have authorized Mark Tamecki to sue the State for damages resulting from an alleged clerical error in title records maintained by the Division of Motor Vehicles, which resulted in Mr. Tamecki's overpayment for a 1979 model truck and in the payment of higher insurance coverage and excise tax.

**LD 27**      **An Act to Amend the Laws Governing Disposition of Lost Goods**      **LV/MD**

### SUMMARY

Under current law, a finder of lost money or goods has a duty to give and post certain notices if the property has a value of \$3 or more and an additional duty to publish notice if the value is \$10 or more. This bill would have retained the same duties, but increased the dollar value amounts at which the duties are imposed to \$300 and \$500.

**LD 35**      **An Act to Change the Date for Statewide Primary Election**      **ONTP**

### SUMMARY

This bill would have changed the date for statewide primaries from the 2nd Tuesday in June to the 2nd Tuesday in September. See also LD 310.

**LD 37**      **An Act Related to Pool Enclosures within 150 Feet of a Lake or Stream (By Request)**      **LV/MD**

### SUMMARY

This bill would have exempted a swimming pool located within 150 feet of a great pond, stream or other shoreland zoning area from the law requiring fences around swimming pools.
