#### **SUMMARY**

This bill would have allowed certified breeders to administer rabies shots to domestic animals. The bill would have required the Department of Agriculture, Food and Rural Resources to establish qualifications for certified breeders and maintain a registry of certified breeders.

#### **SUMMARY**

The original bill would have exempted filling a freshwater wetland and construction of facilities in a freshwater wetland for the purpose of cranberry cultivation or cultivation of other wetland crops from the permitting process under natural resources protection law. The majority report, Committee Amendment "A"(H - 175), amended the bill to exempt only those cranberry cultivation projects certified by the Department of Agriculture, Food and Rural Resources. The amendment established certification procedures and requirements. Certain classifications of wetlands were not eligible for certification under the proposed requirements. The department would have been afforded 45 days to review an application and issue certification if all requirements had been met.

The minority report, Committee Amendment "B" (H-176), differed from the majority report in that the Department of Environmental Protection would have been the agency directed to certify cranberry cultivation projects. Certification requirements and procedures were the same as in the majority report except that the department could have deferred action beyond the 45 day period when winter conditions prevented evaluation of the proposed site.

House Amendment "A" (H-266) to Committee Amendment "A" (H-175) replaced the majority report. This amendment provides a general permit process to facilitate the consideration of cranberry cultivation projects in certain types of wetlands. Persons seeking to cultivate cranberries in compliance with the terms of the general permit do not require individual permits from the Department of Environmental Protection. The department is afforded a 45-day review period prior to any development of a proposed cranberry cultivation site located in a wetland. During the review period the department may determine whether or not the proposed project meets the provisions of the general permit. The Department of Agriculture, Food and Rural Resources is charged with certifying the adequacy of the cranberry cultivation practices proposed by the applicant.

#### **SUMMARY**

This bill proposes to amend laws pertaining to the enforcement of the Potato Branding Laws. Inspection of potatoes in transit would be prohibited. Refusing access to an inspector would no longer be a separate violation of the branding laws.

### An Act to Facilitate the Reimbursement of Deposits on Pesticide Containers

#### **SUMMARY**

This bill would have required inspectors with the Board of Pesticides Control to verify triple rinsing of pesticides containers during their normal course of work if the inspector were at a location where pesticide containers were stored and the owner of the containers requested inspection. Authorized collection, disposal, or recycling facilities require verification of triple rinsing prior to accepting the containers. Currently, inspectors schedule certain days to be on site at landfills to verify triple rinsing at the time of disposal.

#### **SUMMARY**

This bill proposed a vehicle for citizens to initiate investigations of alleged improper manure handling. The bill would have required the Commissioner of Environmental Protection to respond to a citizens' petition and determine if water quality had been affected by manure spreading or other manure handling practices. Current law provides for the Department of Agriculture, Food and Rural Resources to investigate complaints of improper manure handling and to advise the Department of Environmental Protection if a potential water quality violation exists.
