All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 183

An Act to Ensure Proper Disposal of Waste at Marinas

AMENDMENTS ADOPTED

SUMMARY

This bill would have required all marinas that provide slip space and moorings to watercraft to provide pump-out facilities for disposal of sewage. This bill also would have established the Marina Pump-out Facility Loan Fund to assist marinas in meeting the requirements of this bill.

LD 193

An Act to Permit Larger Docks Within the Saco River Corridor

SUMMARY

At the time this bill was submitted, Maine law required that no privately owned pier, dock or float on the Ossipee River, Little Ossipee River and freshwater portions of the Saco River may extend more than 10% of the width of the river at any time or extend into the water more than 10 feet perpendicular to the shore, whichever is less. This bill would have increased the allowable dock size from 10 feet to a 20-foot extension from the shore.

An Act Regarding Zoning Variances

SUMMARY

Under current law, municipalities, in considering applications for zoning variances, must determine whether strict application of a zoning ordinance would cause undue hardship. One factor in determining undue hardship is whether the land in question can yield a reasonable return. This bill proposed to amend the law to limit the application of the reasonable return question to the land, exclusive of any buildings or appurtenances attached to that land.

This bill also provided that variances be granted to applicants for the sole purpose of making property more accessible to disabled persons unless the Department of Environmental Protection finds that the alteration or construction would have a definite negative impact on the environment.

Committee amendment "A" (H-48) strikes the provisions of the bill affecting the manner in which a zoning board of appeals would determine undue hardship when considering requests for zoning variances. The amendment adds language clarifying the bill's intent to allow municipal zoning boards of appeal to grant variances for the construction or installation of structures or equipment solely intended to improve accessibility for a person living on the property who has a disability, as defined in the Maine Human Rights Act, the Maine Revised Statutes, Title 5, section 4553.
