All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 170 An Act to Increase the Death Benefits under the Workers'

SUMMARY

This bill increased death benefits from \$4,000 to \$10,000 and incidental benefits from \$3,000 to \$8,000 for employees who die as a result of the injury.

LD 172 required premium pay for work performed on a Sunday by any employee of a manufacturing facility with over 250 employees that normally operates for 24 hours a day. The bill did not require an employer to pay an employee who works overtime on a Sunday more than the double time required under the bill.

The Committee selected this bill from several similar bills relating to premium pay on Sundays to carry over.

This bill assessed self-insurers \$100 per day and insurance carriers \$1,000 per day for failure to pay workers' compensation benefits after a decision requiring payment.

SUMMARY

LD 199 established the Commission to Study the Use of Professional Strikebreakers. The commission would study the use of professional strikebreakers in labor disputes and evaluate its impact upon collective bargaining between employees and their employers.

Committee Amendment "A" (H-185) increased the appropriation in the bill to provide sufficient funds for contractual services and added a fiscal note.

Senate Amendment "A" (S-421) required that the approval of the Executive Director of the Legislative Council be obtained prior to hiring of a consultant for the study.

SUMMARY

LD 200 provided for the state minimum wage to be adjusted annually by the percentage increase or decrease change in the state average weekly wage for the 2nd year previous to the adjustment. This adjustment was subject to 3 limitations. First, the adjustment could not exceed 5% in any single year. Second, the adjustment would be rounded off to the nearest 5¢ increment. Finally, if the federal minimum wage was increased to a rate above the state level, the state minimum wage would be increased to the same amount and the succeeding year's adjustment would not be made since the new federal wage would establish a new "base rate" from which future adjustments would be calculated.

SUMMARY

This bill established the Apportionment Disability Fund to pay workers' compensation benefits to injured employees when compensability is not disputed, only the respective responsibility of 2 or more insurers. The fund would be initially funded by a one-time assessment of 1/4% on actual paid losses of all workers' compensation insurers and self-insurers, with reimbursement to the fund from the parties later determined to be responsible.
