### JOINT STANDING COMMITTEE BILL SUMMARIES

#### AUGUST 1991

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

#### **SUMMARY**

This bill proposed amendments to the natural resources protection laws that would have allowed permits to be granted that limited the time a development could be used if such a limitation on time would mitigate the development's impact on wildlife.

Committee amendment "A" (S-43) replaced the bill. The amendment requires the Governor, when making appointments to the Maine Land Use Regulation Commission, to actively seek and give consideration to persons residing on coastal unorganized islands.

#### **SUMMARY**

This bill would have authorized expedited erosion control on the shoreline of Sebago Lake in the Town of Standish. It authorized the placement, construction or repair of riprap, retaining walls or erosion control devices on land adjacent to Sebago Lake within the Town of Standish with a permit from the Standish code enforcement officer. Under current law, such placement, construction or repair requires a permit from the Department of Environmental Protection.

#### **SUMMARY**

The original bill required state agencies and municipalities to use water conservation devices whenever possible. Provisions of this bill were incorporated into LD 804.

#### 10 •Energy & Natural Resources

The committee amendment (H-331) replaced the bill with Part A of LD 77 to continue the Commission to Study Maine's Oil Spill Clean-up Preparedness until June 30, 1992. This amendment:

- 1. Extends the allocation of existing funds for the commission until June 30, 1992. The bill does not allocate any new funds for the commission;
- 2. Requires the Department of Environmental Protection to provide reports to the commission by June 30, 1991, and quarterly thereafter, on:
  - A. Its progress in rulemaking;
  - B. The state oil spill contingency plan;
  - C. The sensitive area identification and protection system;
  - D. The wildlife rehabilitation plan;
  - E. The possibility of a Gulf of Maine oil spill compact; and
  - F. The availability of oily debris disposal facilities; and
- 3. Requires the commission to report to the Legislature by November 1, 1991, on:
  - A. The progress of the new federal, state and industry response initiatives;
  - B. The relationship between the new federal fund and the existing Maine Coastal and Inland Surface Oil Clean-up Fund; and
  - C. Any recommendations for further state legislative or administrative action.

A Senate amendment (S-390) adds two more members to the commission.

This bill would have replaced the current definition of aseptic packaging with the substance of the
