All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

The bill would have modified, to a limited extent, joint and several liability in medical malpractice cases only. Each defendant would have been responsible for only that defendant's portion of the noneconomic damages, but would have remained jointly liable for all economic damages.

SUMMARY

The bill would prohibit surrogate parenting contracts as against public policy and therefore not legal or binding in this State. The so-called surrogate mother would be considered the child's mother and the rights of the other parties to the contract or their spouses would be determined under existing paternity, custody and adoption laws of this State. Any fee paid beyond actual medical expenses would be placed in trust for the child. Compensated brokerage services would be prohibited as a Class D crime.
