All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

#### **SUMMARY**

This bill would have clarified the applicability of the laws governing site location of development. The bill would have established the concept of "integrated development scheme" to replace the "common scheme of development" provisions of existing Department of Environmental Protection rules.

The bill also would have transferred the responsibility for deciding whether the traffic requirements of the site location of development laws have been satisfied from the Department of Environmental Protection to the Commissioner of Transportation.

## SUMMARY

This bill proposed to exempt existing transfer stations, stump dumps, recycling centers or facilities

that handle white goods, tires or brush from additional engineering or operational requirements as part of their relicensing.

Committee amendment "A" (H-181) changed the title and replaced the bill. Under this amendment, transfer stations, including associated uses permitted by license, and recycling facilities are not required to be relicensed unless the engineering or operational standards in effect at the time the previous license was issued are changed or if the facility significantly changes its operations. Solid waste license requirements for wood waste and demolition debris landfills associated with transfer stations are not affected by this amendment.

## LD 420 An Act Concerning Overboard Discharge Inspection Fees PUBLIC 294

#### **SUMMARY**

This bill, as amended by Committee amendment "A" (H-256) allows people with overboard discharge licenses to waive state inspection if they have entered into an ongoing maintenance contract that includes inspection and have paid a \$30 waiver fee. Copies of these contracts and the results of inspections must be filed with the Department of Environmental Protection. The committee amendment also provides enforcement provisions and requires the Commissioner of Environmental Protection to report to the Legislature by 1993 on the waiver program. This amendment also adjusts the allocations affected by the bill and adds a fiscal note.

House amendment "A" (H-418) makes a technical correction regarding the determination of gross income under the sliding license fee schedule of 38 MRSA §414, sub-§3-A.
