This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

The resolve directs the Commissioner of Corrections to develop a plan for the employment of adult inmates in all state correctional facilities and report to the Legislature by December 1, 1991.

**SUMMARY**

During the Second Regular Session of the 114th Legislature, a "hold back" was created in the community corrections program, whereby 30% of corrections reimbursement due to each county must be held back by the Department of Corrections until the county demonstrates that the funds will be used to develop community corrections programs.

This bill requires that the held back funds be placed in an interest bearing account, and that interest be paid to a county when its funds are released.

Committee Amendment "A" (S-83) adds an allocation section and fiscal note to the bill.

This bill has been carried over to the Second Regular Session.
