SUMMARY

This bill provided patrons of the Maine State Archives the same right to privacy as is provided to patrons of libraries in Maine, clarified the status of an optical disk that is not erasable as an acceptable storage medium for records admissible in court proceedings and changed the class of crime from Class D to Class E for persons who violate the provisions of the local government records law.

This bill would have directed the Secretary of State to hold a special advisory referendum at the next special statewide election to determine whether the voters of the State favor the establishment of a coal-fired, energy producing plant with the capacity of burning 1,500 tons of coal per day.
