This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**SUMMARY**

The bill clarifies that the Maine Hospice Council shall submit a budget that enables it to carry out its statutory responsibilities. The bill provides funds to the Maine Hospice Council.

Committee Amendment "A" (H-159) removes the appropriation to the Council.

**SUMMARY**

This bill requires the court to determine the amount that parents can afford to contribute to the cost of their childrens' care when the Bureau of Mental Retardation is appointed guardian. The amount determined by the court is paid to the Bureau of Mental Retardation. Currently, a parent is no longer financially responsible when the Bureau becomes guardian.
